Selection of Prize Winner:

ICCU will randomly select a winner from the pool of eligible entries. The winner will be notified by Monday, September 14, 2026.

Eligible participants must be 18 years of age or older, must be legal residents of the States of Idaho, Washington, Arizona, or Oregon, and must possess a valid government-issued driver's license or other form of photo identification, such as a state-issued ID Card or passport.
